



# The Calontir Song Survey

This spring I conducted an informal survey to see how well people knew songs in the "Calontir Playlist". Respondents were asked to rank their familiarity with 43 songs from the following choices:

- I can lead it
- I can sing along if someone else leads
- I can hum along
- I don't know it at all

The survey gained over 50 responses. Below are some highlights:

## Best Known:

The song with the most people that could lead it was *Non Nobis* with 68%. That one was a bit of a freebie since it has so few lyrics. There was a tie for second place between *Raven Banner* (52%) and *Song of the Shieldwall* (52%). Warrior's Wyrd came in a close second place at 48%.

## Least Known:

The song that the largest number of people said they didn't know at all was *Hind Horn* (68%). Again, that one was a bit of an oddity as Erich is about the only person that tends to lead it. In second place was *Gather Ye Pipers* by Mikal Hrafspa (56%). This is a song that used to be more popular, but I think has fallen out of rotation in recent years. Tied for third place was a pair of lullabys: Mordred's Lullaby by Heather Dale, and Fyldraka's Lullaby, by Selene of Lesbos. Both of these have been sung quite a bit in circles recently, so I have a funny suspicion that more people know them than the survey lets on.

## Underestimation:

A song that stood out to me as many people saying they didn't know it was *Benevento* by Hyrim de Guillon with 38% of respondents saying they weren't familiar at all. I suspect this is a case of people simply not knowing the name of this song as I regularly hear people sing along with it.

## Overestimation:

Respondents have a surprisingly high estimation on whether they could lead the song at 40% when asked about *Savage Daughter*. Given how frequently I've heard everyone enthusiastically sing the chorus and then look around in confusion, waiting for someone to help them with the verse, I'm skeptical on this figure.

## The Group Sing:

There's some songs that everyone seems to know, but not quite well enough to lead. In first place here was *Drums of War* by Adalyde Heloyz la Cantora with 52% of respondents saying they could sing along if someone else led. There was a tie for second place between *Cheer* by Fernando and Lyriel and *Compact Between Horse and Man* by Dorcas at 52%. In third place was *Battle of Maldon* by Rosalind Jehanne.

## Balance:

The song that was the most evenly divided between all four categories was *Conn's Song (The Moon Shines Brightly)* by Conn MacNeill. For this song, 28% said they could lead, 30% could sing along, 22% could at least hum, and 20% didn't know it.



# Financial Policy Update

Greetings from your resident Exchequer! We are currently in the midst of our fiscal year, and so it's time for an update on our finances. We are doing great in terms of our bank account and have a healthy balance in the bank. Acts of service by volunteering at events we host, being autocrat for an event or hosting a site dinner are great ways to help ensure our Barony continues to be financially healthy! A big thank you to everyone who has been involved in acts of service to our Barony, big or small!

Definitely consider hosting a site dinner! If you don't want to host, come and eat food! This is a great way to support the barony through food, friends, fun, and, of course, donations (\$5.00 min per person). It's like a big family dinner! Site dinners have brought in anywhere from \$250.00 to \$800.00, which sometimes is enough to cover the site fee for the Webster Groves Masonic Temple and/or our storage unit. This can also help us to keep gate fees reasonable for events we host, which is great for everyone!

Lady Apple (B3R Quarter Master) and I will be completing an inventory list of all the items at the storage unit in October. This is required by Kingdom Policy. We will be reaching out to all B3R members who keep gold key items for an inventory list. If you hold Gold Key items, please reach out to Lady Apple.

## 1. Financial Committee and Financial Policy

- a. The financial committee shall consist of the exchequer, the seneschal, and the baronage (which shall have one vote total, regardless of the number). All must be active, paid members of the Society. Lapse in membership status will result in removal from the financial committee until dues are paid. At least three members of the financial committee must be involved in all financial decisions.
- b. The financial committee shall meet at least quarterly.
- c. The financial committee, in the person of the seneschal and/or exchequer, shall present annual budgets for baronial offices and one-time budgets for baronial events to the populace during monthly business meetings, asking for a simple vocal yea/nay vote for such expenditures.
- d. Proposed expenditures and budgets should be presented for approval at the Baronial Officers meeting at least 2 weeks prior to the expenditure of funds to allow time for review.
- e. Approved receipts presented for reimbursement should be paid immediately.
- f. Proposed changes to the financial policy will be approved by the financial committee, either in person or via email and must be approved by the Kingdom before becoming effective. The policy will be reviewed each time the exchequer is replaced or at least biannually.
- g. If, due to medical, political, or other extenuating circumstances, the financial committee is unable to meet in person, a meeting via Zoom or another, similar online forum shall suffice.

## 2. Reporting requirements and schedule for reports to branch administration.

- a. Quarterly financial reports shall be created by the exchequer in accordance with baronial and society regulations and completed by the 15th day of the month following the end of the quarter.
- b. The quarterly financial reports will be submitted to the Barony Seneschal for review prior to submitting it to the Kingdom Exchequer. It also will be available to branch members upon request.

## 3. Bank Account

- a. All funds will be managed through a group bank account. Under no circumstances may baronial funds be handled through personal accounts.
- b. Two signatures will be required on any check, money order, or other instrument of withdrawal, whether or not the bank offers signature inspection. Automatic teller machine (ATM) or debit cards are forbidden.
- c. Any individual who is a signatory on an account will not sign a check from that account in the name of himself or herself.

d. Signatories on the Account

- i. The exchequer, seneschal, and Kingdom Exchequer (or designated representative) are required signatories on the account. At least one other Barony member should be a signatory with the exchequer's deputy or the immediate proceeding exchequer preferred.
- ii. The signatories may not be related by blood or marriage, or reside at the same address.
- iii. Royalty and their heirs may not be signatories.
- iv. All account signatories must be paid members of the SCA Inc.
- v. Upon being added as a signatory to an account, all individuals will submit evidence of personal legal identification to the bank and legal name, address, and proof of membership to the branch exchequer.

e. The baronial account should never be allowed to fall below \$3,000.00.

f. The group checkbook shall be maintained and kept in the possession of the group exchequer.

4. Methods for controlling cash receipts.

- a. All incoming funds will be deposited before being disbursed for any purposes.
- b. All checks will be endorsed prior to depositing.
- c. All funds will be deposited within ten (10) days of receipt.

5. Disbursing funds.

- a. Reimbursements will only be made for expenses approved in advance by the financial committee.
- b. Reimbursements will only be made within 30 days of the expense and upon presentment of appropriate receipts. Extensions may be granted by contacting the exchequer and seneschal in cases where presenting receipts is not possible within 30 days. FP-109
- c. Event Refunds when Pre-Registration is available: The Event Steward must receive requests for pre-registration refunds in writing, postmarked or e-mailed no later than 3 days prior to the event. Refund requests should include the same information that was submitted in your registration (you should have received an email when you registered). Refunds will only be paid via check from the hosting group after the event is over and the account has processed. A processing fee of \$5 or the PayPal processing fee, whichever is greater, will be charged to all refunds for PayPal reservations.

d. Expense authorization requests should be emailed to the Financial Committee one week prior to the next Baronial Officers meeting to give the committee time to discuss and gather any additional required information. Input may be given by officers and populace, but final approval is made by the Financial Committee.

e. If the Barony dissolves for whatever reason, any group funds shall escheat to the Kingdom or other Society Branch and the Kingdom Exchequer must be notified as to the disbursement of said funds.

## 6. Event admission charges or complimentary passes.

a. Royalty (including Crown, heirs, and visiting royalty) shall not be charged site or feast fees. They will still be required to sign the gate forms.

b. Barony of Three Rivers Territorial Baronage shall not be charged site or feast fees.

c. All minor site fees will be discounted with respect to adult site fees.

d. Event Steward(s) shall not be charged a site fee. This shall be written into all event bids.

e. Feast Steward(s) shall not be charged a site or feast fee. This shall be written into all event bids that include feast.

f. Food may be provided to servers at feast without charge.

g. The Counting Table staff at Winter Court shall not be charged a feast fee. This shall be written into the Winter Court Bid.

h. Non-members may not receive complimentary passes (SFP VIII.A.8).

i. Contractual obligations may be exempted on a case by case basis.

## 7. Event procedures.

a. Prospective Autocrats for proposed events must submit a bid that includes the following information:

i. A written description of the event, including activities and proposed site.

ii. A proposed event budget, detailing the estimated income and expenses for this event, including tithes, pre-registration and/or paypal payments, comped persons, as applicable.

Keep in mind:

iii. Registration should pay for the site tokens, camping fees, general equestrian site fee, hall rental, hall cleaning equipment and supplies, general activity supplies, prizes, and anything else not covered by another income source.

iii. Registration should pay for the site tokens, camping fees, general equestrian site fee, hall rental, hall cleaning equipment and supplies, general activity supplies, prizes, and anything else not covered by another income source.

iv. The feast registration should cover the cost of food, beverages, rental equipment, feast tokens, kitchen cleaning equipment and supplies, etc. used to provide the feast. If servers or kitchen help eat free, the paying attendees must cover their costs.

v. Class registration if an additional charge should cover the expenses of any supplies or rental equipment incurred by the class apart from the general site costs, such as craft supplies, or honoraria for a guest speaker..

b. All checks must be made out to "SCA, Inc.-Barony of Three Rivers." All personal checks received in lieu of cash by a Branch will include the individual's name, full address, and phone number. FP-107.

FP-107: All personal checks received in lieu of cash by a Branch or Guild Chancellor of the Exchequer will include the individual's name, full address, and phone number.

c. Gate Forms must be completed by gate staff for each transaction.

d. All monies collected at event gates will be reconciled against the Gate Form tally at least daily for multiple day events, and at the closing of Gate.

e. Completing the Gate Forms after the event is expressly forbidden.

f. If the event expenses go over-budget, this will be taken to the Financial Committee for additional approval of funds.

g. The exchequer will report the number of non-members having attended their events within 10 business of the event and forward the appropriate funds and documentation to the Kingdom Exchequer or designated representative within the time constraints set by the Kingdom.

h. All event receipts must be presented to the exchequer for reimbursement within 25 days of the event close.

i. Event reports will be submitted to the Barony and the Kingdom within 30 days of the event close.
